#### Information collected by Lohxa

- Voluntarily provided information or Legally required information:
  - Personal Information
    - In order to be able to provide services to you the following information may be collected: Name, address, phone number, email address, place of employment, occupation, qualifications.
  - Facility information
    - In order to be able to provide services to you the following information may be collected: Facility name, facility type (i.e hospital pharmacy, long term care pharmacy, outpatient facility, etc.), address (i.e physical location of facility, corporate headquarters, etc.), phone numbers, email addresses, licensing/registration information (i.e State Board of Pharmacy, State Controlled Substance license/registration, Drug Enforcement Agency registration (DEA), etc.)
- Information that is collected by visiting our website:

How your information is used:
